# Tender Notice for Selection of Plumbing and related services for Works at Embassy, Embassy Residence and Official Residences of India Based Officers

Embassy of India, Ljubljana invites quotations from the trained, experienced and professional Plumbers (self employed/agencies) on a contract for annual basis for various plumbing works in Chancery, Embassy Residence and official residences of India based officials (06 residences).

- 2. The agencies/self employed service providers interested and meeting eligibility criteria may submit their quotes as per enclosed format by email to <a href="mailto:adm.ljubljana@mea.gov.in">adm.ljubljana@mea.gov.in</a> or in a sealed cover superscribing "Offer for Annual Contract for Plumbing services in E/I, Ljubljana" latest by 12:00 hrs on 08 November 2021.
- 3. The offer documents will be opened on 10<sup>th</sup> November 2021 at 14:00 hrs at Embassy of India, Ljubljana in the presence of participant or their representatives who choose to attend.

## **Nature of Work**

The plumber who intends to apply for above work should have valid license issued by the competent authority and should be able to render the services in the capacity of licensed Plumbers.

2. The work involves plumbing jobs like drain cleaning, water tap maintenance, leakage/seepage issues, flooding of house due to severe blockage, servicing of taps etc and replacement as and when required in the premises and submission of report after work.

**<u>Eligibility Criteria</u>** The contractor should fulfill the minimum criteria as per the details given below.

## A. Agency:

- i. The contractors should have registered office in Ljubljana
- ii. Should have valid registration and tax number.
- iii. Should possess valid license for the work.
- iv. They should have experience of similar works preferably with other Embassies and government departments/ residential complexes
- v. They should have sufficient number of plumbers for attending work in case the main plumber is not able to visit.
- vi. The agency/individual should follow safety guidelines and in case of any accident/unforeseen event, service provider shall be fully reponsible.
- vii. Should not have any criminal/legal/police case against them.

### B. Self Employed

- i. The service provider should be based in Liubliana
- ii. Should have valid registration and tax number.
- iii. Should possess valid license for the work.
- iv. He should have experience of similar works preferably with other Embassies and government departments/ residential complexes
- v. He should have sufficient number of expert and experienced (carrying valid ID & Tax number) Assistants for attending work in case the main plumber is not able to visit.
- vi. The individual should follow safety guidelines and in case of any accident/unforeseen event, service provider shall be fully reponsible.
- vii. Should not have any criminal/legal/police case against them.

## **Instructions to the Applicants:**

- 1. The intending contractors are advised to enclose photocopies of all relevant documents as mentioned in the eligibility criteria and bring the originals of the same at the time of opening of the bids
- Intending applicants are required to submit details of their full biodata/agencies full details, experience as per Annexure-I and service charges as per Annexure-II.
- Incomplete applications or applications without proper proofs for establishing their credentials may not be considered for shortlisting the agencies, individuals for final selection.
- 4. Each page of the quotation document shall be signed as acceptance of terms and conditions.
- 5. The offer documents are liable for rejection due to incorporation of any false information and furnishing fake documents.

### **General terms and Conditions**

- 1. The agency may select one or more than one agency if the offered prices are similar.
- 2. The contract will be valid for a period of 01 year from the date of signing. The period of contract may be further extended for 01 year subjected to satisfactory performance by the agency at the existing rate and terms.
- 3. There should not be any change of rate during the contract period. Any change of rate during the contract period will not be paid and contract will be cancelled with immediate effect.
- 4. The Embassy also reserves the right to accept or reject any or all the applications and/or withdraw or cancel or suspend this notification without assigning any reason.
- 5. Applications received after due date and time or incomplete in any respect are liable to be rejected.
- 6. The decision of the Embassy in selection of vendors for selection will be final.
