Essential Requirements:

- i. <u>Educational qualifications and experience:</u> Minimum 3 years degree in Yoga with 3 years of experience or 2 years diploma/certificate from renowned registered Indian institutions with 4 years of experience in teaching of Yoga in institutions to the mixed inter-cultural pupils/yoga enthusiast.
- ii. <u>Eligibility</u>: Slovene nationals, third country nationals/Non Resident Indian with valid resident permits provided by the Government of Slovenia.
- iii. <u>Language Proficiency:</u> Fluency in English and Slovenian (speaking, reading and writing). Knowledge of other language will be value addition.

iv. Mandatory:

- a) Degree/Diploma as mentioned in para 3(i)
- b) Experience in teaching of Yoga as mentioned in para 3(i)
- c) Experience in giving performance/lecture demonstrations
- d) Ability to prepare lesson plans, workout tests and evaluate performance of lessons.

v. Desirable:

- a) Sound knowledge in use of computers including recording/downloading audio/video, mixing and editing video from the Youtube/internet
- b) Adequate knowledge of history, philosophy and traditions of Indian music, dance, art and culture.
- 4. **Remuneration:** Selected yoga teacher will be paid remuneration in the form of honorarium at the monthly rate of **Euro 1250.00**.

In addition, tests may be conducted to assist the selection board in assessing the applicant's qualifications, skills and language ability. Reference verification shall be conducted as a part of the hiring process.
- 7. <u>Conditions of Employment (MUST BE MET):</u> The appointment of the successful candidate will be subject to a reliability check obtained by the Management. To conduct the reliability check, the candidate will have to submit the following documents on being selected by the Mission:
