### Additional Information

- Visa Free Countries : Nationals of Nepal and Bhutan do not need a visa to enter India. However, Nepali nationals require visa if they enter India from China, which is granted **GRATIS**
- **GRATIS Visa** : Nationals of Afghanistan, Argentina (restricted to Tourist, Business and Transit visas only), Bangladesh, Mongolia, DPR Korea, Jamaica, Maldives, Mauritius, South Africa and Uruguay (Tourist only), Seychelles (Work/Employment Visas)
- Business and Employment Visas to be issued GRATIS, **ICWF to be charged**, to the following countries as JS (CPV)'s email dated 14.12.2015 -Afghanistan, Angola, Bangladesh, Benin, Bhutan, Burkina Faso, Burundi, Cambodia, Central Africa Republic , Chad, Comoros, Democratic Republic of Congo, Djibouti, Equatorial Guinea, Eritrea , Ethiopia, Gambia, Guinea, Guinea -Bissau, Haiti, Laos People's Democratic Republic, Lesotho, Liberia, Madagascar, Malawi, Mali, Mauritania, Mozambique, Myanmar, Nepal, Niger, Rwanda, Sao Tome and Principe, Senegal , Sierra Leone, Solomon Island, Somalia, South Sudan, Sudan, Timor-Leste, Togo, Tuvalu, Uganda, |United Rep.
